

PRIVACY NOTICE

(Effective: 01.11.2019)

This Privacy Notice contains basic information on the management, processing and recording of any personal data provided by the User when using the Controller's Website.

The Privacy Notice may be amended at any time, and the User must check the Website from time to time to ensure that he/she is aware of any changes. The Privacy Notice will enter into force on 01 November 2019.

This notice has been drawn up in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive (EC) 95/46/EC (General Data Protection Regulation, hereinafter: "GDPR").

Data processing, legal basis for data processing

Legal basis for data processing: consent of the User pursuant to Article 6 (1) point (a) of the GDPR.

Users of the <https://www.hobafers.hu> website are not required to provide any information when using the website. The Data Controller collects data about the User during visiting the website by means of cookies and pixel tags. By using this website, the user consents to the processing of data related to his/her browsing behaviour, of which he/she will be informed.

The User acknowledges that if he/she prohibits the use of his/her personal data, he/she will not be able to access or use the map route search service, or only to a limited extent.

The collection of data through cookies and pixel tags covers the following:

- the start and end times of the User's visit to the website, the length of time the User spends on the site,
- the IP address of the User (only when using the map route search),
- content visited on the site, subpages viewed,
 - the type of browser used by the User,
- indicating the operating system and device the User uses,
- search data of the User used within the website,
- Facebook identification data and Google identification data of the User,
- and the fact of viewing a third-party website or service that the User used before communicating with the website.

The Data Controller will not combine this data with other personal data.

The User may withdraw his/her consent at any time. The withdrawal of consent does not affect the lawfulness of processing based on consent prior to the withdrawal. The data subject may withdraw his or her consent in writing, sent to the following e-mail address:

Purpose of data processing

The purpose of data processing is to improve the user experience, to improve the services of the website and to provide as much information as possible about the services available through the website. The Data Controller uses the data generated in its

computer system for statistical purposes, to measure the number of visits and traffic to the website.

No profiling or automated decision-making is carried out in connection with data processing.

Data transfer

Personal data will not be transferred to third parties, third countries or international organisations.

The Data Controller uses the assistance of a data processor for the processing of personal data for statistical purposesP

Duration of data processing

The Data Controller stores the personal data for 30 days, after which they are deleted.

The Data Controller cannot link the statistical data it collects to the User's personal data after the data have been generated.

If the User wishes to modify or delete the search engine settings (hereinafter referred to as "cookies") related to the Website, he/she may do so in the settings of the browser used to access the Website, since cookies are stored on the User's computer and not on the Website Operator. The User can find more information about these in the Help section of the browser he/she is using, and may change his/her previous cookie settings, or delete cookies previously set by the Operator on his/her device used for browsing.

Users' rights regarding the processing of their personal data

Rights in relation to data processing

The User **may request** from the Data Controller, in writing, through the contact details provided in point a), **information** on what personal data the Data Controller processes, on what legal basis, for what processing purposes, from what source, for how long, as well

as to whom, when, on the basis of what legislation, to which personal data the Data Controller has granted access or to whom the Data Controller has transferred the data.

The User may request in writing from the Data Controller, through the contact details set out in point a), the **rectification (amendment), addition or deletion of** personal data concerning him/her, with regard to the purpose of the processing, **and may object to** the processing of such personal data.

The Data Controller shall comply with the request without undue delay, and shall notify the User of the measure or the reason for non-action within 1 month at the latest. The 1-month deadline may be extended by 2 months with regard to the complexity of the request and the number of requests. The Data Controller shall inform the User of the extension of the time limit, stating the reasons for the delay, within 1 month of receipt of the request.

The User may request in writing from the Data Controller, through the contact details provided in point (a), that the Data Controller **restrict the processing of personal data**, if the User:

disputes the accuracy of the data, for the duration of the accuracy check by the Data Controller,

contests the lawfulness of the processing and requests the restriction of the use of the data,

requests it for the establishment, exercise or defence of legal claims, even though the Controller no longer needs the personal data,

objects to the processing of personal data, for the period until it is established whether the legitimate grounds of the Data Controller prevail over the legitimate grounds of the User.

Right to data portability: The User has the right to receive personal data concerning him or her in a structured, commonly used, machine-readable format and the right to transmit such data to another controller without hindrance by the Controller, if the processing is based on a contract to which the Data Subject is a party or if the processing is based on the Data Subject's consent and the processing is carried out by automated means. The User may also request, where technically feasible, the direct transfer of personal data between data controllers.

Data security

The Data Controller shall take all necessary security, organisational and technical measures to ensure the protection of the privacy of the data subjects. The Controller shall take appropriate technical and personnel measures to protect the personal data it processes against, inter alia, unauthorised access or unauthorised alteration (e.g.
